TOUR TERMS & CONDITIONS

Terms Effective March 1, 2021 — Subject to Change

1. DEPOSITS:

Registrations require a signed and dated **Kenneth Mills Tour Registration Form** and a **\$500 deposit per person**.

Submission of Deposit and Signed or Unsigned Registration Form constitutes a binding contract.

2. PAYMENT SCHEDULE:

- **YOUR DEPOSIT must be received by Friday, April 23.** Deposits received after this date face the risk of not having space on the tour.
- **YOUR FINAL PAYMENT must be received by Monday, July 26.**

Payments received later will be assessed \$250 per person and must be paid by a Cashier's Check or Money Order. If final payment is not received by 75 days prior to departure, the participant's tour space will be canceled and all payments forfeited.

3. TOUR CANCELLATION:

Written cancellation must be sent directly to Kenneth Mills Tours. Participant must receive confirmation of cancellation.

Cancellations (for any reason whatsoever) are subject to a **\$50 Kenneth Mills Tours administrative fee**.

- Canceling 60-90 days prior: \$500 fee
- Canceling 45-60 days prior: 50% of tour price assessed
- Canceling 0-45 days prior: 100% of tour price assessed
- There are no refunds for international or in-country tickets once issued!

4. DEPOSITS & FINAL PAYMENTS:

Deposits and Final Payments are payable to **Kenneth Mills Tours**.

5. FINAL DOCUMENTS:

Final tour documents will be available one week before departure to facilitate any last minute changes.

6. AIR TRANSPORTATION:

Individuals are to make their own flight arrangements to and from Cairo for this trip. Flights in Egypt at the beginning of our Nile cruise and at the end of our cruise are included in the price of the tour.

7. HOTELS:

Prices are based on 5-star hotel rooms (Egyptian ratings). If changed, similarly priced hotels are used. Single room occupants (for any reason) must pay single room surcharge.

8. MEALS:

Daily breakfasts & dinners. Three meals a day are included on the cruise.

9. ENTRANCE FEES:

Entrance fees are included for all activities unless item is listed as optional.

10. GUIDES:

English-speaking guides are provided.

11. PORTERAGE:

Overseas portage of 1 suitcase is included. The fee for additional suitcases/flight bags is \$2 per hotel for each in/out.

12. LUGGAGE:

Group touring is limited to one normal size suitcase (not to exceed 50 lbs) and one carry-on piece.

13. PASSPORTS & VISAS:

Each participant is responsible for a valid passport with an expiration date at least six (6) months after conclusion of tour, and must mail or e-mail to Kenneth Mills Tours a legible copy (do not fax). Copy of passport is required at the time of tour registration. Visas for Egypt are included in the price. Those with non-U.S. passports must advise Kenneth Mills Tours at the time of registration.

14. NO TOBACCO / ALCOHOL POLICY:

The following are not permitted on any part of this tour: Tobacco of any type, Electronic Cigarettes, Vapes, or Alcohol.

15. ITINERARY CHANGES:

The itinerary has been planned under the direction of your tour leader in cooperation with our travel partner in Egypt. It is possible that the daily itinerary may be adjusted by unforeseen circumstances.

16. PRICING FLUCTUATIONS:

Tour prices are based upon current tariffs, agreements and exchange rates in effect at the time of brochure production, March 2021. These factors are outside the control of Kenneth Mills Tours, and will be defined by Kenneth Mills Tours at least 60 days before departure. If the fuel surcharges increase any time prior to ticketing you will be assessed.

17. TRAVEL INSURANCE:

KMT and/or its agents will not be responsible for any damage or expenses or inconvenience caused by late registrations, late airplanes, trains, boats, or changes in any of their schedules due to strikes or any other reason whatsoever. KMT will not be responsible for the loss or damage to luggage or any passenger's personal belongings. KMT recommends the purchase of Travel Insurance to cover such events. KMT reserves the right to refuse any person as a tour member at any time before or during the actual tour. KMT reserves the right to cancel, change, or withdraw the tour in whole or in part at any time. The sole obligation of KMT is to refund payments received in connection herewith if not acceptable by tour members. Refunds for canceled fares and services abroad for any reason will be made only after having been received from the airlines, hotels, or companies performing these services, less any out-of-pocket expenses incurred by the operation resulting from those cancellations and will follow the guidelines herein contained for cancellations.
