TOUR TERMS & CONDITIONS

*Terms & Conditions Also Apply to the JORDAN EXTENSION for this tour
Terms Effective June 1, 2023 — Subject to Change*

1. DEPOSITS:

Registrations require a signed and dated **Kenneth Mills Tour Registration Form** and a **\$500 deposit per person**.

Submission of Deposit and Signed OR Unsigned Registration Form constitutes a binding contract.

2. PAYMENT SCHEDULE:

- **YOUR DEPOSIT must be received by Tuesday, February 22, 2024.** Deposits received after this date face the risk of not having space on the tour.
- **YOUR FINAL PAYMENT must be received by Tuesday, April 9, 2024.**

Payments received later will be assessed \$250 per person and must be paid by a Cashier's Check or Money Order. If final payment is not received by 75 days prior to departure, the participant's tour space will be canceled and all payments forfeited.

3. TOUR CANCELLATION:

Written cancellation must be sent directly to Kenneth Mills Tours. Participant must receive confirmation of cancellation. Cancellations (for any reason whatsoever) are subject to a **\$50 Kenneth Mills Tours administrative fee.**

- Canceling 60-90 days prior: \$500 fee
- Canceling 45-60 days prior: 50% of tour price assessed
- Canceling 0-45 days prior: 100% of tour price assessed
- There are no refunds for international or in-country tickets once issued!

4. DEPOSITS & FINAL PAYMENTS:

Deposits and Final Payments are payable to **Kenneth Mills Tours LLC.**

5. EARLY DEADLINES:

In order to facilitate scheduling for both KMT and participants, and because of the tour needing a minimum of 26 participants, there may be a "go/no go" decision made 150-180 days prior to scheduled tour.

6. FINAL DOCUMENTS:

Final tour documents will be available one week before departure to facilitate any last minute changes.

7. AIR TRANSPORTATION:

Individuals not flying with the group at the complete tour price are to make their own flight arrangements to and from Tel Aviv for this trip.

8. HOTELS:

Prices are based on 4- and 5-star hotel rooms (Israel ratings). If changed, similarly priced hotels

are used. Single room occupants (for any reason) must pay single room surcharge.

9. MEALS:

See itinerary for breakfast & dinner schedule.

10. ENTRANCE FEES:

Entrance fees are included for all activities unless item is listed as optional.

11. GUIDES:

English-speaking guides are provided.

12. PORTERAGE:

Overseas portage of 1 suitcase is included. The fee for additional suitcases/flight bags is \$2 per hotel for each in/out.

13. LUGGAGE:

Group touring is limited to one normal size suitcase (not to exceed 50 lbs) and one carry-on piece.

14. PASSPORTS & VISAS:

Each participant is responsible for a valid passport with an expiration date at least six (6) months after conclusion of tour, and must mail or e-mail to Kenneth Mills Tours a legible copy (do not fax). Copy of passport is required at the time of tour registration. Those with non-U.S. passports must advise Kenneth Mills Tours at the time of registration.

15. NO TOBACCO / ALCOHOL POLICY:

The following are not permitted on any part of this tour: Tobacco of any type, Electronic Cigarettes, Vapes, or Alcohol.

16. ITINERARY CHANGES:

The itinerary has been planned under the direction of your tour leader in cooperation with our travel partner in Israel. It is possible that the daily itinerary may be adjusted by unforeseen circumstances.

17. PRICING FLUCTUATIONS:

Tour prices are based upon current tariffs, agreements and exchange rates in effect at the time of brochure production, June 2023. These factors are outside the control of Kenneth Mills Tours, and will be defined by Kenneth Mills Tours at least 60 days before departure. If the fuel surcharges increase any time prior to ticketing you will be assessed.

18. TRAVEL INSURANCE:
